# Do I need a Will?

## A comprehensive guide to Will writing

For many of us, death, or the prospect of death is something they would rather not think about. ### What is a Will?

A Will is a written document which directs how a person's possessions and estate will be distributed when they die. Among other requirements, a Will may appoint executors to administer an estate, name a guardian for a child, and/or make arrangement for payment of duties.


#### Do I Need a Solicitor to Make a Will?

No, you do not need to appoint a Solicitor to make a Will, however it is advisable. A solicitor will check a Will you have drawn up to make sure it will have the effect you want. This is because it is easy to make mistakes and if there are errors in the Will, this can cause problems after your death. Sorting out misunderstandings and disputes after your death may result in considerable legal costs, which will reduce the amount of money in the estate. A Solicitor can also offer valuable advice on your Will, help draft your Will, meet with you to get the Will signed and store the original for you on your behalf.



## Why make a Will?

A Will is one of the most important legal documents that you will ever sign. By making a Will you will be able to retain some control into what happens to your estate after you have died. When you die your property and affairs will need to be dealt with. If you die without making a Will, the choice of how your possessions and estate is dealt with is taken away from you. Whist professional legal advice can't stop the inevitable it can help you control what comes before and what happens after.

- Provision for your pets
- Wills can include 'Discretionary and Disability Trusts' to make provision for vulnerable beneficiaries who may not be able to manage their own finances and affairs
- Asset Protection Trusts to help secure assets for future generations, such as a Property Trust.
